Certified Surgical Scrub Technician:

The Certified Surgical Scrub Technician must have equivalent qualifications and competence as employed individuals performing the same or similar services at the facility.

Definition of Care of Service:

The Certified Surgical Scrub Technician functions as a member of the surgical team and may perform various duties to facilitate surgical cases. The Surgical Technician will be able to demonstrate the knowledge and skills necessary to provide assistance during surgical procedures performed in the department.

- Experienced in all aspects of aseptic technique;
- Setting up the required equipment and sterile supplies as needed for their assigned cases;
- Pulling cases as needed, breaking down cases at the end of the procedure.
- Knowledgeable regarding instrumentation, equipment and supply needs for all types of surgical procedures.
- The Surgery Technician performs delegated duties consistent with his/her scope of practice and functions within the philosophy and overall plan of care delivery.
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians

Setting(s):

• Healthcare facilities including but not limited to hospital operating rooms and ambulatory surgical centers with surgical service areas

Supervision requirements:

- Direct supervision by the physician
 - \circ $\;$ Indirect supervision by the surgical department director, site manager or designee

Evaluator: Surgical department director in conjunction with supervising physician or designee

Qualifications

- High School degree or higher
- Graduation from an accredited surgical technology program
- For Colorado: Registration as a Surgical Tech by Colorado Division of Regulatory Agencies (DORA)
- Certified as Surgical Technologist
- American Heart Association or Red Cross health care provider BLS Certification
- NOTE: Where education may not be defined in qualifications area of the Scope, HCA Healthcare requires the

highest level of education completed (not training or courses) confirmed on your background check.

State Requirements:

• Must be currently registered with the State of Colorado Department of Regulatory Agencies-DORA when working in Colorado

Experience:

• One year experience as a surgical tech

Preferred Experience:

• One year of operating room experience is preferred.

Competencies

The Certified Surgical Scrub Technician will demonstrate:

- Provides a safe environment for patients
 - o Uses at least two ways to identify patients before treating or performing a procedure
 - Labels containers used for blood and specimens in the presence of the patient
 - Labels all medications and solutions on and off the sterile field in perioperative and procedural settings
 - Participates in the pre-procedure process to verify the correct procedure, for the correct patient, at the correct site and involves the patient in the verification process when possible
 - Participates in a time-out immediately before starting an invasive procedure or making the incision
- Basic aseptic technique
 - o Applies sterile attire including scrubbing, gowning and gloving
 - o Uses sterile technique for scrubbing, gowning and gloving of other personnel
 - Organizes sterile drapes
 - Receives sterile equipment via circulating nurse using sterile technique
 - Assists with patient dressing application
- Effective communication and interpersonal skills
 - Coordinates case preparation
 - o Transfers sterile instruments to surgeon accurately
 - o Anticipates surgeon needs
 - o Assists with care of instruments at end of case
 - o Demonstrates working knowledge of anatomy and physiology
- Infection Prevention
 - Practices consistent hand hygiene
 - Uses personal protective equipment (PPE) when required
 - Required immunizations per Division requirements
 - o Complies with Isolation precautions
 - Maintains sterile field
