The Non-Certified Surgical Technologist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The Non-Certified Surgical Technologist acts as an assistant to a surgeon during a surgical procedure. Scope of Service may include:

- Prepares instruments, supplies and equipment essential to the surgical procedure
- Maintains the sterile field
- Passes instruments and anticipates needs of the surgeons
- Assists the surgeon by providing retraction and aiding exposure of the operative site.
- Anticipates the moves of the surgeon and assists in the safe and efficient completion of the surgical procedure
- Facilitates hemostasis of the surgical site by performing suction, irrigation and sponging the operative site during a surgical procedure
- Assists with skin or external suturing and stapling
- Assists with securing drainage systems and dressings
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
