- Supervise behavioral health consults and mental health evaluations with resident and faculty physicians
- Participate in didactic teaching of residents
- Serve as an advisor for resident committees and activities
- Oversee Balint-like case discussion groups for all residents
- Participate in quality improvement and patient safety activities to improve efficiency and clinical care
- Develop and implement curriculum for the resident rotations in behavioral and community health, assuring that ACGME standards are met
- Assist in ensuring ACGME FMRC accreditation requirements are met
- Participate in the evaluation process of residents
- Provide education and guidance in matters of physician well-being
- Participate in the evaluation of residency applicants and recruitment of new residents
- Develop own focus of scholarly activities
- Attend family medicine faculty and resident meetings, conference, committees and retreats
- Participate in faculty development activities
- Infection Prevention
 - Practices consistent hand hygiene
 - Uses personal protective equipment (PPE) when required
 - Required immunizations per Division requirements
 - Complies with Isolation precautions
 - Maintains sterile field
