<p><b>Licensed Clinical Social Worker:</b> The Licensed Clinical Social Worker must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p><b>Definition of Care or Service:</b> The Licensed Clinical Social Worker collaborates with the hospital’s case management and interdisciplinary healthcare team in an effort to meet facility resource management expectations and enhance patient outcomes. Utilizes professional social work knowledge, relationship skills, and interdisciplinary collaboration to assess and intervene in psychosocial issues significant to patients/families and the healthcare team’s management of illness, injury, and disability. They will work on counseling and helping their clients with whatever issues they may be having. Scope of service may include:</p> <ul style="list-style-type: none"> <li>• Establish and maintain a relationship of mutual respect, acceptance, and trust</li> <li>• Gather and interpret social, personal, environmental, and health information</li> <li>• Evaluate and treat problems within their scope of practice</li> <li>• Establish achievable treatment goals with the client</li> <li>• Facilitate cognitive, affective, and behavioral changes consistent with treatment goals</li> <li>• Evaluate the effectiveness of treatment services provided to the client</li> <li>• Identify appropriate resources and assessment instruments, , crisis intervention, and supportive counseling as needed</li> <li>• Advocate for client services</li> <li>• Collaborate effectively with other social work or allied professionals, when appropriate.</li> <li>• Advocacy and protective work whenever there are issues of abuse, neglect, or violence</li> <li>• Discharge planning-arranging transfers for individuals, either home with services or to other hospitals or rehab facilities</li> <li>• Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.</li> </ul>
