The Clinical Music Practitioner must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The Clinical Music Practitioner provides a service that uses the inherent healing elements of therapeutic music and sound to enhance the environment for patients in healthcare settings, making it more conducive to the human healing process.

Scope of service may include:

- Observe patient's needs; sleep, pain relief, anxiety, etc.
- Choose music appropriate to condition and hospital environment
- Vary music according to patient's reactions or special requests
- Establish rapport with patient and family as a representative of the hospital
- Hand out Clinical Music Survey to track effectiveness of services.
- Ability to be self-directed and organize plan of visits independently.
- Seek input from nurses and staff on patients who might best benefit from music services.
- Tune and Maintain hospital's musical instruments and equipment (ex. Harp)
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
