<p>Non-Certified Sonographer: The Non-Certified Sonographer must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p>Definition of Care or Service: The Non-Certified Sonographer uses special equipment to direct high frequency sound waves into areas of the patient’s body for diagnostic evaluation. Scope of Service may include:</p> <ul style="list-style-type: none"> • Operates equipment that collects reflected echoes and forms an image that may be videotaped, transmitted or photographed for interpretation and diagnosis by physician • Reviews patient medical history • Explains the procedure to the patient • Positions the patient for exam • Uses sonography equipment to perform diagnostic examination <ul style="list-style-type: none"> ○ Selects and stores images ○ Takes measurements, calculates values, and analyzes preliminary findings ○ Adjusts, maintains and cleans sonography equipment • Documents the procedure in the medical record • Maintains and secures patient images and records • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
