Scope of Service may include:</p> <ul style="list-style-type: none"> • Prepares instruments, supplies and equipment essential to the surgical procedure • Maintains the sterile field • Passes instruments and anticipates needs of the surgeons • Assists the surgeon by providing retraction and aiding exposure of the operative site. • Anticipates the moves of the surgeon and assists in the safe and efficient completion of the surgical procedure • Facilitates hemostasis of the surgical site by performing suction, irrigation and sponging the operative site during a surgical procedure • Assists with skin or external suturing and stapling • Assists with securing drainage systems and dressings • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
