Certified Peer Recovery Specialist: The Certified Peer Recovery Specialist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.
Definition of Care or Service: The Certified Peer Recovery Specialist will work with Emergency Department patients who are identified with opioid use and mental health concerns, and insured by Medicare. The peer specialist will work with the identified patients who have the desire to engage in peer support to improve their individual health. Scope of service may include: <ul style="list-style-type: none"> Proficiency in providing peer support and recovery coaching. Knowledge of the addiction recovery process and principles of a recovery-oriented system of care. Knowledge of program management. Proven relationship-building abilities. Familiarity with recovery community, services, and resources. Understanding of and ability to maintain appropriate boundaries. Cultural competency skills and experience with culturally diverse populations. Strong customer service ethic. Demonstrated excellence in written and oral communication skills. Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
