Extracorporeal Membrane Oxygenation Technicians (ECMO TECHS):

The ECMO Tech must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The ECMO Tech assists physicians in the procedure that uses a machine to take over the work of the lungs and sometimes the heart. Scope of Service may include:

- Develops treatment plan involving:
 - Assessments
 - o Planning
 - o Implementation
 - Evaluation
 - o Education
- Responsible for assisting and support of the ECMO team
- Prepares and operated machine during ECMO, which includes determination and calculation of requirements for each patient.
- Monitors equipment closely during procedure for any changes in patients condition and informs physician immediately
- Correlates and records data obtained during the procedure.
