<p>Electromyography Technicians (EMG Tech): The EMG Tech must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p>Definition of Care or Service: The Electromyography Technician (EMG Tech) assists in procedures that uses electromyographic equipment to map out normal and abnormal signals and determine whether there has been subtle nerve damage or paralysis to diagnose disorders of the brain. Scope of Service may include:</p> <ul style="list-style-type: none"> • Perform nerve conduction studies • Obtain a patient's medical history and brief them on the procedure • Operate electromyographic equipment to assist physicians in conducting electrophysiological tests such as nerve conduction velocity, muscle strength and repetitive stimulation • Prepare recordings and reports of findings for physicians to aid in the diagnosis of neuromuscular disorders • Monitors equipment closely during procedure for any changes in patients condition and informs physician immediately • Correlates and records data obtained during the procedure. • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
